Field Service Personnel

The Middleton Cross Plains School District year ended in early June which saw the transition of our two School Resource Officers out of the school. Typically, SRO's are assigned to their respective schools for two years, with an option for a third year. Officer Travis Kakuske was assigned to Middleton High School for three years and Officer Matt Sherry was at Kromrey Middle School for three years. Both officers had successful tenures at their schools. Officer Kakuske is transitioning to third shift patrol. Officer Matt Sherry left his employment with the Middleton Police Department shortly after the

end of the school year. Matt's wife recently graduated from the University of Wisconsin as a Physician Assistant and accepted a job in Minnesota. Matt was hired as an officer by the Rodgers, Minnesota Police Department. Matt will be missed by his colleagues and friends in Middleton.

Both officers were recognized at the June 5, 2012, School Board meeting for their dedication to the youth of our community.

The loss of Officer Sherry leaves the Department three officers short of our authorized strength. A hiring process is currently underway.

Middleton Detectives Patricia Faust and Daniel Jones were assigned to assist the Fitchburg Police Department on their recent homicide.

Field Services

In May, Middleton Officers handled 1,699 calls for service, 670 were field initiated, 1,029 were dispatched, issued 580 citations and 89 written warnings, made 30 criminal arrests and investigated 39 accidents.

In June, Middleton Officers handled 1,625 calls for service, 536 were field initiated, 1,089 were dispatched, issued 433 citations and 78 written warnings, made 14 criminal arrests and investigated 398 accidents.

The Police Department took 12 theft from vehicle complaints in June, in most cases the vehicles were unlocked. In one case, a vehicle was entered on Middleton Beach Road and a GPS taken. The GPS was sold at a pawn store in La Crosse and detectives are following up on the suspect.

TRAFFIC ENFORCEMENT ACTIVITIES

On June 5, Sgt. Mueller attended the quarterly Dane County Traffic Safety Commission meeting. The Commission is going to become involved in the student driver-education program in Dane County to see if we can add input to what is taught so that it can benefit our traffic safety goals. It was announced that in August over 500 miles of highways throughout the state will have rumble strips installed as part of a pilot project, some will be within Dane County. The Governor's Conference on Highway Safety will be August 28 and 29, all are encouraged to attend. So far this year, statewide, the fatality total is 24, ahead of 2011's tally.

The annual Rhythm and Booms celebration was on June 30 and Middleton Officers assisted in maintaining smooth traffic flow for those leaving the event at the end of the festivities.

Twelve hours of overtime Seat Belt Enforcement grant patrols were performed on June 2 during the night shift. Thirteen enforcement actions were taken. Two citations for Speed with four warnings, four citations for Seatbelt, one citation for Wrong Way on Divided Highway, one citation for Insurance and two Equipment warnings were issued.

One four hour shift was done for the SMART grant on Hwy 12. Six citations for Speeding were issued and one warning for lane deviation.

About 20 hours of regular patrol directed traffic enforcement was performed. Streets targeted included: Airport Road, Century Avenue, N Gammon Road, Parmenter Street, Pheasant Branch Road and Highways Q and 12. Seventy-six enforcement actions were taken: 43 citations for Speed and one warning, ten citations for Seatbelt, 14 citations for Insurance, two citations for OAR/OAS, two citations for Failure to Obey Sign and three citations with one warning for Registration.

In June there were 38 reportable accidents of which nine were parking lot accidents. This compares to 2011's 26 of which six were parking lot accidents.

INVESTIGATIVE UNIT REPORT

Each year, the Police Department observes an increase in call activity during the warmer months as citizens increase their daily outdoor activities enjoying the beautiful summer weather. Increases in burglaries, thefts, frauds and domestic incidents are frequent calls

officers respond to during warmer months. With the overall increase in police calls, the Investigative Unit reviews and assigns more cases to detectives for follow up. For June, a total of 77 incidents were forwarded to the Investigative Unit for review with 20 of these cases being assigned to a detective for additional follow up.

The Investigate Unit continues to work with other local authorities in attempting to solve two local bank robberies which occurred in September of 2011 and again in May of this year. It is believed the same individual is responsible for both of these robberies in the City of Middleton, a number of bank robberies in the Dane County area and a number of robberies in surrounding states. Detective Haselow has been working with the local FBI office and the Madison Police Department in hopes of solving all of these robberies.

At the end of the month, the Police Department took a very disturbing report regarding a father sexually and physically abusing his children for approximately the last two years at a residence in the City of Middleton. Detective Faust was assigned this case for follow up and worked with a number of local agencies to gather detailed statements from the children and to offer the family assistance during this difficult time. The father was arrested and taken to the Dane County jail and has been tentatively charged with 2nd degree sexual assault, child enticement, sexual assault of a child, battery and disorderly conduct while armed. Additional charges could be forthcoming and additional follow up will likely be needed as this case proceeds through the court system. Incidents such as these can be very draining emotionally and physically for the officers and detectives who are assigned to investigate these unthinkable cases. Large amounts of time are devoted to cases such as these and the troubling details can be difficult for even the most seasoned officers and investigators.
